
#### **Working Group Updates**

Our incredible Working Groups have dedicated hours and months to this process and are preparing to wrap up their contribution at the end of this year. Our unbounded gratitude for the expertise and passion they have brought to the process. Working Groups have completed drafted their recommendations, based on months of research and evaluation. The recommendations are identified as Action and/or Gap. Action recommendations are specific actions, supported by evidence and research, which can be implemented immediately. Action recommendations will provide a clear template for national, state, and community levels to begin creating a culture of water safety for the United States. Gap recommendations identify where additional research or evaluation is need to move the Gap to an Action.

The draft recommendations are being reviewed by the Steering Committee, using a standardized evaluation template for consistency. The role of the Steering Committee is not to change or inform Working Group recommendations, but to move towards consistency in the final Recommendation, begin to identify overlap between recommendations, and to ensure that the final recommendations are complete, backed by evidence, and can be reasonably implemented. As part of the process we are also identifying key words for indexing in a searchable database and for a future glossary of terminology. Our work is all focused on making the USNWSAP a working document that helps you to implement Recommendations in your community and state, while providing the backup documentation needed to lobby for change.

In October, the Working Groups will complete their Models and National Implications - a summary of the recommendations they have developed. From October through December, the work will be reviewed, formatted and moved towards consistent language and format by the Steering Committee, External Reviewers, and the Working Group Chairs.





Once this process is complete, we will begin a Delphi Procedure as a validation and feedback process. And this is where....

Your Participation is Needed!

The USNWSAP Steering Committee is pleased to announce an upcoming opportunity for individuals in drowning prevention, water safety, aquatics, public health, and other related fields to provide input on the USNWSAP's development. Our 6 Working Groups have been busy over the past year conducting an environmental scan to understand the current status of their topic area, writing recommendations based on the environmental scan, and developing models that reflect a water safety community, county, and state. We are asking for your input on the results of our Working Group's process. The results of each of the groups work will be available in the form of 6 different surveys that represent our 6 groups. Each survey will be open for one month for interested parties to complete and provide their feedback as in the form of ratings and providing open ended feedback. After the first round of surveying, the results will be shared with participants

in aggregate form. The surveys will open for a second time for participants to resubmit their ratings and provide any final feedback. This process is a research procedure known as the "Delphi Method". The results of this open surveying process will help the Steering Committee, Working Group Chairs, and our Blue-Ribbon Panel make final decisions about the USNWSAP.

A special email blast will be sent to everyone who has signed up for the newsletter inviting them to participate in the Delphi process, directing you to sign up on the website. We hope you will all participate, and will encourage others in the water safety field to sign up for the newsletter or go directly to the website when the surveys are open. We are fully committed to hearing all voices in the field and incorporating your ideas and concerns. For this to be a plan for the entire U.S., we need to hear from as many of you as possible.

This process will be occurring January 2022-March 2022, so please block out some time on your calendar to make your voice heard.
